COVID-19 Release and Waiver of Liability

COVID-19 has been declared a global pandemic by the World Health Organization. While social distancing efforts have helped to reduce infection rates in many parts of the country, it remains highly contagious. Iglesia de Dios Ministerial de Jesucristo Internacional, Inc. (IDMJI) has developed a COVID-19 prevention plan in conjunction with applicable local, state, and federal regulations and guidance to reduce the likelihood of the spread of COVID-19 on IDMJI premises. However, even with this prevention plan in place, IDMJI cannot guarantee the safety of individuals who enter its premises. As a result, all individuals must complete and sign this COVID-19 Release and Waiver of liability (the "Release") in order to be eligible to enter IDMJI premises.

Assumption of Risk

I, along with my minor child or children or any minor child or children under my legal guardianship (individually and collectively referred to as "Participants"), voluntarily assume the risk that entering IDMJI premises may expose Participants to or cause Participants to become infected by COVID-19. Participants further acknowledge that such exposure or infection may result in personal injury, illness, permanent disability, or death. Participants assert that they are in good health and free from the following symptoms of COVID-19: fever, cough, shortness of breath, chills, muscle pain, headache, sore throat, or new loss of taste or smell. Participants understand and acknowledge if they or anyone in their household has any of these symptoms, they will not be allowed to enter IDMJI premises until they are cleared by a doctor. Participants further agree to immediately inform IDMJI if Participants, anyone in Participants' household, or anyone with whom members of Participants' household have been in physical contact tests positive for COVID-19. Participants agree to be responsible for their own personal safety and actions while on IDMJI premises and to comply with all IDMJI policies, guidelines, signage, and instructions regarding safety measures related to preventing the spread of COVID-19 while on IDMJI premises.

Waiver and Release

Participants release and forever discharge and hold harmless IDMJI, its directors, officers, employees, agents, related entities, and representatives (collectively the "IDMJI Releasees") from any and all liability, claims, and demands of any kind or nature, either in law or in equity, which arise now or in the future in connection with Participants' presence on IDMJI premises during the global COVID-19 pandemic. Participants further understand and agree that this Release discharges the IDMJI Releasees from any liability or claim that Participants may have against the IDMJI Releasees with respect to bodily injury, illness, death, property damage, or any other harm that may result from Participants' presence on IDMJI premises, including harm caused by the negligence of IDMJI. Participants expressly waive any right to a trial by judge or jury that Participants may otherwise have with regard to any claim or liability related to Participants' presence on IDMJI premises during the global COVID-19 pandemic.

Indemnity

In consideration of and for the right to enter IDMJI premises during the global COVID-19 pandemic, Participants agree to indemnify and hold harmless the IDMJI Releasees from any and all claims, liability, actions, causes of action, debts, claims and demands of any kind or nature, either in law or in equity, which arise now or in the future in connection with Participants' presence on IDMJI premises during the global COVID-19 pandemic.

ACKNOWLEDGMENT READ CAREFULLY BEFORE SIGNING

By subscribing electronically, I acknowledge that I have read this Release and Waiver of Liability in its entirety and, in consideration for the right of myself, my minor child or children, or any minor child or children under my legal guardianship to enter IDMJI premises during the global COVID-19 pandemic, I in good faith make the releases and waivers, assume the responsibilities, and agree to indemnify the IDMJI Releasees as described herein. I further understand that by signing this agreement, I am voluntarily waiving any claims I may have against IDMJI for negligence arising from the presence of myself, my minor child or children, or any minor child or children under my legal guardianship on IDMJI premises during the global COVID-19 pandemic. I acknowledge that I have had an opportunity to ask questions and consult with an attorney of my choosing, and that I freely agree to the terms expressed in return for entry into IDMJI premises.
